
Notes on Officers and Directors Mineral City Mining, Manufacturing and Land Company



W. E. Bibb died 10 December 1910, at 64 years in the City of Richmond (when he had recently removed). He is buried at the Louisa Town Cemetery. The Federa census for Louisa County 1860 census shows a William E. Bibb (11 years); sond William T. and Lucy A. Bibb; his father is a farmer; he has one brother, James I On his tombstone is written, "William Emmet Bibb - 1848-1910- Souther Bibb. Soldier, Virginia Statesman, Christian Gentleman." He became a Master Mason Day Lodge #58 at Louisa Courthouse in 1871 and a Worshipful Master in 1884 at 1893.1 On 28 December 1876, William Emmet Bibb married Kate Lester Cammad Their children were: Janet Herndon; E. Cammack; William Chew; John Pendleton; and Kathleen Bibb.³ He was listed as a principle farmer and as Commonwealth's Attome in the Louisa Directory of 1884. In 1896, William E Bibb owned The Piedmont Hote in the town of Louisa.⁴ In 1907, he qualified as Commonwealth's Attorney an resigned 3 March 1910, to be succeeded by his son W. C. Bibb.⁵ In 1887, he was a Stat Senator representing Louisa in the legislature.⁶

In the resolutions to his death on January 10th 1911, he was called the "oldes surviving member of this bar, member of the State Senate, Commonwealth's Attorney and Attorney General of Virginia."7

J. F. Bickers was a Worshipful Master in the Louisa Courthouse Day Lodge No at the a 58, A.F. & A.M. and petitioned that organization in 1893.⁸ He was born 17 Ma 1866, a son of James Madison Bickers and Julia Etta Bibb Bickers. He died 1 December 1950. He is buried at Oakland Cemetery. Mr. Bickers was at one time: member of the Louisa Board of Supervisors. He had been sheriff of Louisa Count for 20 years. As a tobacco auctioneer, he worked for many years at the Shockhar

Warehouse in Richmond. His children are J. Frank Bickers, Jr., William C. Bickers, a step-daughter, Mrs. J. R. Mathews, and a step-son, Beauford Rogers of Dumbarton. At his death, his wife was Bettie McKean Bickers.⁹ James Frank Bickers married on the 30th May 1888, Sarah E. Bibb, daughter of William T. and Lucy Bibb. At that time he was a deputy sheriff.¹⁰

John William Flannagan was born June 30, 1855, in Missouri and died July 17, 1919. Buried beside him were his children Samuel H. (1891-1893) and Lizzie Lyle (1882-1885). He is buried at Hillcrest Cemetery.¹¹ John W. Flannagan married Bessie Haskins Wills in Louisa on January 20,1881.¹² Bessie W. Flannagan's list of heirs in 1912 were: W. W. (age 43); John W. (age 40); and H. A. (age 38) Flannagan.¹³ John W. Flannagan was the son of W. W. and Sarah E. Flannagan.¹⁴ In 1884, he was listed as a principle farmer at Greensprings Depot. In 1909, he is listed as a cattle dealer at Trevilians. From the Mechanicville voting register, we learn that on July 10, 1888, J. W. Flannagan was a 30-year old farmer at "Cloverdale." He had been in the county and state for 16 years. At that time he moved to Louisa Court House.¹⁵ In 1889 J. W. Flannagan petitioned the Day Lodge No. 58 to become a Master Mason.¹⁶ In 1890 his children were the first baptized at Wills Memorial Church: Wills Waddell; John William, Jr.; and Henry Samuel Flannagan.¹⁷ By November 11, 1891 he had moved back to Trevilians. J. W. Flannagan owned a store in Mineral with R. P. Talley on block 12 called Flannagan and Talley.¹⁸

Weir R. Goodwin was the son of Dr. Edmund P. and Lucy A. Chiles Goodwin of Louisa and was listed as 4 years old in 1860.¹⁹ By 1867, he lived with his mother in the town of Louisa on Depot Street.²⁰ By his first marriage to Lilly Murray Goodwin he had one daughter.²¹ Lilly Marshall Murray was the daughter of Henry W. Murray who moved to Louisa from Ireland to become a prominent Louisa citizen and lawyer. Lily Goodwin died in 1888.²² In 1888, Weir R. Goodwin petitioned from Roanoke to the Masonic Day Lodge No. 58 at Louisa Courthouse. Evidently he moved back to Louisa at the death of his first wife. On October 7, 1895, W. R. Goodwin, a widower, married Virginia C. Chiles, the daughter of Henry and Esa P. Chiles. He listed himself as a tobacconist.²³ He was deputy clerk of Louisa in 1900 and 1909. In 1890, he took the place of R. L. Gordon on the Louisa Town Council. He was a member of the Louisa Town Council 1891, 1894-95, 1901-1908.²⁴ He died 11 July 1910, at 56 years in Roanoke.²⁵ Resolutions of respect are found in the Louisa Law Order Book 1904-II to Weir Randolph Goodwin for his service to Louisa County.²⁶

At his death in 1910, he left his second wife, Virgie C. Goodwin, and two children: Virginia R. Goodwin and W. R. Goodwin from this marriage. His widow married Frank T. West, Louisa school superintendent.²⁷

R. Lindsay Gordon, Jr. died in a Richmond Hospital the 25th of December 1939, at the age of 84 years. He was survived by his wife, Mary Gordon, and his son, R. Lindsay Gordon, 3rd. He had two sisters, Bettie and Lucy Gordon, and one brother, **A. T.** Gordon of Louisa. He is buried in Oakland Cemetery.²⁸ His first marriage was to Alice Maud Winston, daughter of William A. and Lucy P. Winston, on 28 October 1884. Alice Maud Gordon died in 1919.²⁹ R. Lindsay Gordon, Jr. was the son of Reuben L. Gordon (1820-1887) and Eliza Somerville Beale, daughter of William C. Beale, and grandson of William F. and Elizabeth Lindsay Gordon.³⁰ He was born 21 January 1855, at Edgewood in Albemarle County ³¹. He moved to Louisa County where he practiced law. R. Lindsay Gordon was the Constitutional Convention

Representative from Louisa County in 1901-2.³² He held the office of Commonwealth' Attorney of Louisa County for sixteen years until 1914. At that time, he ran for the House of Delegates to which he was elected. He retired from this office in 1928. He was the chairman of the House Committee on Insurance and Banking and was a leading member of several other committees.³³

Philip Barton Porter was born in Louisa County; a son of Jesse J. Porter (Louis County Clerk and Mayor of the Town of Louisa) and Gabrielle Mallory on November 5, 1867.³⁴ He was 79 years of age when he died 4 July 1946, in Augusta County at the home of his daughter, Mrs. Taylor M. Boxley, and was buried at Oakland Cemeter Philip Porter was on the Louisa Town Council from 1911 to 1917.³⁵ He was Deput Clerk (1913-1935) and County Clerk of Louisa Circuit Court for more than 24 year He succeeded his brother, James E. Porter. Mr. Porter was a former member of the Board of Supervisors, for the Louisa District, and also served as Judge of the Tria Justice Court for some years. He retired in June of 1946.³⁶ He was a cashier at the Bank of Louisa. He was a member of the Presbyterian Church, the Westmoreland Club of Richmond, and a lifetime member of the Virginia Fox Hunters Association He was a member of Masonic Day Lodge No. 58, A.F. & A.M. at Louisa Courthoux and Worshipful Master in 1896. His wife was Bessie Crawford Hanger Porter Fisherville, who died in 1916. Philip Porter had three children: Philip B., Jr. wh married Margery Terrell; Mildred D. who married Taylor M. Boxley;³⁸ and Mrs. I N. Spence of Cherry Point, North Carolina was his third child.³⁹

Dr. Walton Origin Smith was a dentist in the Town of Louisa. Walton O. Smith wa born 16 March 1850.⁴⁰ He was the son of Dr. Edwin L. Smith, also a dentist in th town of Louisa, and Mary Ann Walton Smith. He died 13 October 1910.⁴¹ He wa raised in the present home of Griswold Boxley.⁴² He married Maggie L. Ennis t Caroline County in 1886 on the 13th of December.⁴³ He and his family lived in th old Louisa Hospital and later next to the Hadder House. He was on the Louisa Tow Council from 1877 to 1879 and 1884 to 1890 and 1899 to 1905 when he resigned.

Robert P. Talley was the son of Joseph C. Talley and Mary S. Carroll who marriedi Louisa County 29 Oct. 1851, in the Methodist Episcopal Church. Robert P. Talleyw born about 1852 as he is listed in the 1860 census as aged 8 years. His father was h depot agent at Trevilians. He was married to Lula M. Talley. They had two sons bon in Louisa: Robert M. on February 1, 1887, and Robert P. on 21 February 1882. Inth 1880 census, we find Robert (age 28) living with his stepfather Miletus T. Good Louisa County Treasurer, his mother, and Lula Talley (19 years). The Talley famil and Gooch family lived at "Grey Gables" in Louisa County. In her will, Mary S. Good listed Robert P. Talley as her grandson, a child of her son, as her heir on 28 Jul 1894.⁴⁴

Robert P. Talley was a member of the Louisa Town Council from 1888 to 1891 Robert P. Talley was a merchant.⁴⁵ He is listed as a merchant at Louisa Courthoux in Chataigne's Gazetteer in his store Flannagan (S. H.) & Talley.
